

ORDER

The State Commissioner for Persons with Disabilities, Kerala has forwarded the order of the Kerala Agricultural University (read.2) to implement the relaxation in age and marks required for the qualifying examinations that are being given to SC/ST candidates to the students applied for the Persons with Disabilities (PwD) quota based on the order of the Kerala State Commissioner for Persons with Disabilities in the case OP(RPWD) No. 1291/S3/2022 (ref.1) vide the letter referred 3 above and directed the University to intimate the report on the same.

As per the letter referred 4 above, the State Commissioner for Persons with disabilities, Kerala has conducted an online hearing with the Registrar or his nominees of all the Universities in Kerala and the Commissioner for Entrance Examinations, Kerala regarding the relaxations given to the applicants under Persons with Disabilities act in age and in the marks of the qualifying examinations for various academic programme. In this hearing, the Commissioner has directed all the Universities to implement the same relaxation to PwD students in all Universities in Kerala. Earlier, in the light of Rights of Persons with Disabilities Act, 2016 the University has reserved 5 percentage seats to the students applied under PwD quota. The matter regarding relaxation of age and marks in qualifying exams to PwD students as per the directions of the Kerala State Commissioner for Persons with Disabilities, has been placed for discussion in the 35th Academic Council.

In consonance with the decisions of the 35th Academic Council meeting, sanction is hereby accorded to implement the relaxations that are being given to SC/ST candidate in the age and mark in the qualifying examinations, to the candidates applying under Persons with Disability quota also, while taking admission to various programme of the University.
